THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF WILSON AUTOSPORTS, LLC, a Florida limited liability company (the "Company"), are executed by the undersigned member of the Company, for the purposes set forth herein:

1. The name of the limited liability company is WILSON AUTOSPORTS, LLC.

2. The Articles of Organization were filed with the Florida Department of State on January 14, 2020, with an effective date of January 13, 2020, and assigned document number L20000009265.

3. The Company has adopted the following amendments to the Articles of Organization:

I. Article II is hereby amended and restated in its entirety to read as follows:

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

II. Article VI is hereby amended and restated in its entirety to read as follows:
