

1. Name. The name of the limited liability Company (hereinafter referred to as "Company") is: HUDSON FARMS - TAYLOR, L.L.C.

2. Existence. The Company shall have perpetual existence commencing with the date of filing.

3. Location. The street address of the principal office and mailing address of the Company is 3369 SW 47th Court, Bell, Florida, 32619.

4. Purpose. The purpose for which the limited liability company is organized is to own and operate timber land property.

5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the Company is 3369 SW 47th Court, Bell, Florida, 32619, and the name of its initial registered agent at such address is RICHARD A. HUDSON.

6. Additional Members. The members may admit such additional members on such terms and conditions as they may unanimously agree.


7. Continuation.
