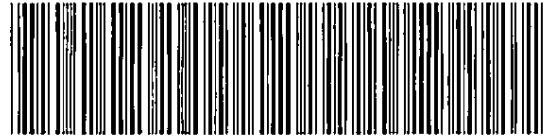

## **ARTICLE X - AMENDMENT**

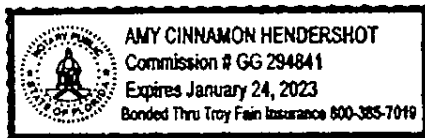

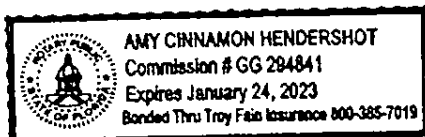
