# ARTICLES OF ORGANIZATION OF TPG PASSIVE INVESTMENTS 20-BF1 LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

#### ARTICLE I Name

The name of the limited liability company shall be TPG Passive Investments 20-BF1 LLC.

#### ARTICLE II Address and Place of Business

#### ARTICLE III Period of Duration
