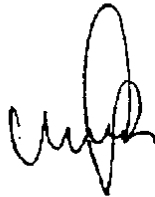

### **Continuity of Life**

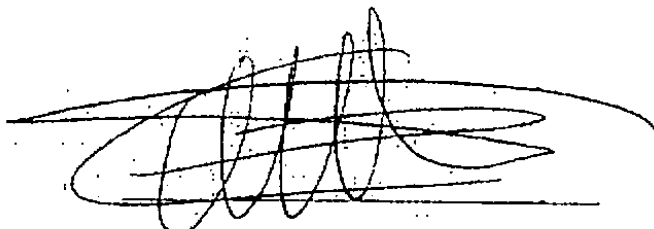
