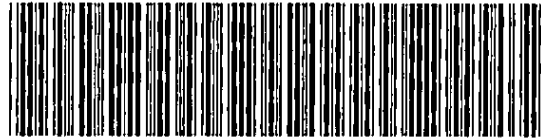

The name of the Limited Liability Company shall be TALL TALE, LLC.


