Amendment to Articles of Organization of MCMB-TSTK LLC

- 1. Article VI.(A) is hereby deleted and in its place and stead the following is hereby substituted:
 - A. <u>Purpose</u>. The Company's business and purpose shall consist of the acquisition, ownership, operation and management of real estate and such activities as are necessary, incidental or appropriate in connection therewith.
- 2. Article VI.(F)(b) is hereby deleted and in its place and stead the following is hereby substituted:
 - (b) borrow money or incur indebtedness other than normal trade accounts payable and lease obligations in the normal course of business (subject to the limitations contained in the security instrument), or grant consensual liens on its property; except that the Company is hereby authorized to obtain financing secured by the lien on the property evidenced by a Mortgage, Assignment of Rents and Leases, Collateral Assignment of Property Documents, Security Agreement and Fixture Filing filed in the official public records of the county in which the Property is located for the benefit of a lender (the "Mortgage"), and to obtain such other indebtedness expressly permitted therein or in the documents related to the Mortgage;
