**ARTICLES OF ORGANIZATION

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Chubby Meg, LLC (the "Company"). The Company's principal address and mailing address is 6319 Memorial Highway, Tampa, Florida 33615. 

**Indemnification**




