**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
CHUBBY MEG, LLC**

Chubby Meg, LLC, a Florida Limited Liability Company (the "Company"), whose Document Number is L20000015003 and whose Articles of Organization were filed on January 21, 2020, hereby certifies as follows:

1. The Articles of Organization of the Company are hereby amended by deleting the present form of Article I, in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is 12642 Bassbrook Ln., LLC (the "Company"). The Company's principal address and mailing address is 6319 Memorial Highway, Tampa, Florida 33615.
