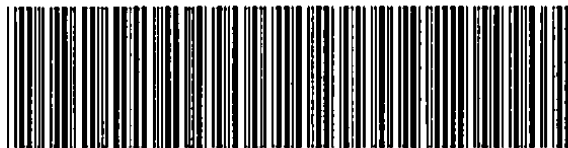

#### **ARTICLE VI – ADMISSION OF NEW MEMBERS**



## ARTICLE VII – MEMBERS’ RIGHT TO CONTINUE BUSINESS


