Both documents should be mailed in together along with the appropriate fees of \$25.00 for the dissolution and \$ 70.00 for the new articles of incorporation, to ensure the filing process is uninterrupted. (Because of the nature of this filing, it cannot be completed online.)

Please return your document, along with a copy of this letter, within 60 days or your filing will be considered abandoned.
