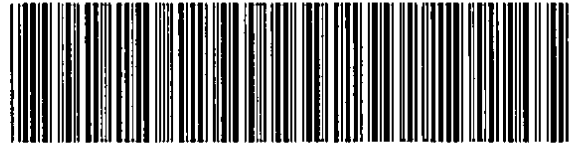

C. A new Article VII is added as follows:


ARTICLE VII - MEMBERSHIP
