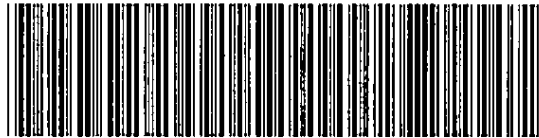



**ARTICLES OF ORGANIZATION
OF
ANDREW BURTCHELL, O.D., PLLC**

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Professional Limited Liability Company hereby being formed under Chapter 621 Florida Statutes, the Florida Professional Service Corporation and Limited Liability Company Act, does hereby adopt the following Articles of Organization for the Professional Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Andrew Burtchell, O.D., PLLC

SECOND: The term of existence of the Professional Limited Liability Company shall be perpetual.

THIRD: The purposes of the Professional Limited Liability Company are to render professional licensed Optometry services; to enter into and perform contracts and agreements of any kind necessary to, in connection with or incidental to the business of the Professional Limited Liability Company; and to carry on any other activities necessary to, in connection with or incidental to the foregoing, as the Manager in his discretion may deem desirable.

FOURTH: The mailing address and street address of the initial registered office of the Professional Limited Liability Company in Florida is 212 West Intendencia Street, Pensacola, Florida 32502, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in Florida at that address is Edsel F. Matthews, Jr..

Having been named as registered agent and to accept service of process for the above stated professional limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

FIFTH: The mailing address and principal office of the Professional Limited Liability Company is 8825 Burning Tree Road, Pensacola, Florida 32502.

SIXTH: The Limited Liability Company is to be managed by the Manager. The names and addresses of the initial Manager are: Andrew Burtchell, O.D., having an address at 8825 Burning Tree Road,

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the sole Member is \$100.00. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may hereafter may be agreed by the unanimous vote of the Members. No additional capital contributions have been agreed to by the Members at this time.


NINTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.


