ARTICLES OF ORGANIZATION
of
COPLAN HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Coplan Holdings, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 4251 University Blvd S #101, Jacksonville, Florida 32216.

ARTICLE II

PURPOSES AND POWERS

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The managers shall be elected in the manner set forth in the Operating Agreement of the Company. The managers shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating Agreement.
