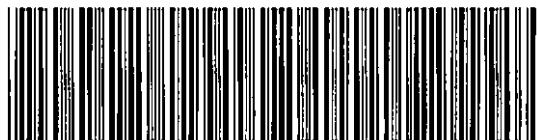


Dear Florida Bar:
