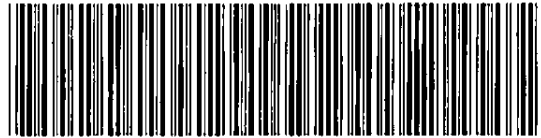

Background

- A. Bryan William Schmied and Arica Joy Schmied (the "Parties") entered into the contract (the "Contract") dated January 15, 2020, for the purpose of: Marketing and Advertisement.

Miscellaneous Terms

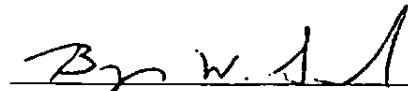

Governing Law


4. Subject to the terms of the Contract, it is the intention of the Parties that this Agreement, and all suits and special proceedings under this Agreement, be construed in accordance with and governed, to the exclusion of the law of any other forum, by the laws of the State of Florida, without regard to the jurisdiction in which any action or special proceeding may be instituted.
