AGREED ORDER RESOLVING AND CLOSING CASE

THIS CAUSE, having come before the Court upon Plaintiff's Amended Motion for Judgment on the Pleadings as to the Complaint, filed on May 24, 2023, upon Plaintiff's Motion to Dismiss the Amended Counterclaim, filed on May 24, 2023, and the Court, being duly advised that the parties are in agreement to the entry of this Order, and being otherwise fully advised in the premises, it is hereby **ORDERED AND ADJUDGED** that:


- A. Plaintiff's Amended Motion for Judgment on the Pleadings as to the Complaint, filed on May 24, 2023, is **GRANTED** in its entirety.
- B. The Order Granting Motion for Temporary Injunction dated April 14, 2022, is hereby converted to a Permanent Injunction, and a final judgment is hereby entered confirming the holdings in Paragraph 30 (a-e) and modifying same to be deemed final and permanent as originally issued with the following revisions to paragraphs (b) and (e) restricting the time frame for same:
 - (b) Declaring that from the date of June 25, 2021, JAYSON LOPEZ had no further relationship whatsoever with PING AN FINANCIAL SERVICES PTE, LLC.

(e) Prohibitively enjoining JAYSON LOPEZ, directly or indirectly, from filing anything in any forum/media, or making any representations, indicating he is currently in any way, shape, or form connected with PING AN FINANCIAL SERVICES PTE, LLC, or that he was so connected subsequent to his removal on June 25, 2021.

- C. The bond in this matter is hereby discharged.
- D. The Plaintiff's claims in the Complaint seeking damages, fees, costs, and interest, as well as the claim for an Accounting, are hereby severed and are dismissed without prejudice, only subject to being reinstated in a brand new proceeding.
- E. Plaintiff's Motion to Dismiss the Amended Counterclaim filed on May 24, 2023, is **GRANTED** and Defendant's claims are dismissed without prejudice, only subject to being reinstated in a brand new proceeding.
- F. This proceeding shall be deemed closed, as all issues have been resolved, or have been otherwise dismissed from this proceeding without prejudice.
