ARTICLES OF ORGANIZATION INA A. COLEN ACADEMY, LLC

These Articles of Organization ("Articles") are adopted, effective this <u>18</u> day of <u>January</u>, 2020, pursuant to Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"). The undersigned sets forth the following:

ARTICLE I NAME

The name of the Limited Liability Company is Ina A. Colen Academy, LLC (the "LLC").

ARTICLE II ADDRESS

The mailing address and principal office of the LLC is: 8435 SW 80th Street, Suite 2, Ocala, Florida 34481.

ARTICLE III MEMBERSHIP AND FORM OF MANAGEMENT

The LLC shall be Manager-Managed within the meaning of Section 605.0407, Florida Statutes, and have a single member consisting of The Colen Family Charitable Trust (the "Member"). The Member is, or has applied to be, a Federal Tax-Exempt Entity. The LLC shall not admit any additional members at any time. The specific purpose for which the LLC is formed is to establish, develop, maintain, improve, manage, and otherwise operate one or more public charter schools and associated uses.
