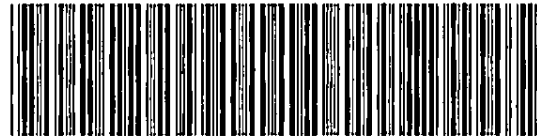



New Members shall be admitted only with the unanimous consent of, and upon terms unanimously approved by, all of the Members.


ARTICLE VII – MEMBERS’ RIGHTS TO CONTINUE BUSINESS

ARTICLE VIII - REGISTERED OFFICE AND REGISTERED AGENT



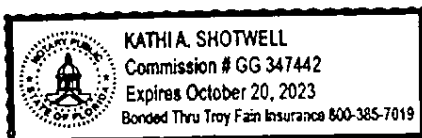
