ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following amendment (the "Amendment") was adopted to the Articles of Organization of GLOBAL RESEARCH ASSOCIATES LLC, a Florida limited liability company ("the Company") originally filed with the Secretary of State, State of Florida on January 31, 2020, and assigned Florida document number L20000030659.

1. Amendment. Articles 1 and 5 of the Company's Articles of Organization are hereby amended so as to read, after Amendment, as follows:


