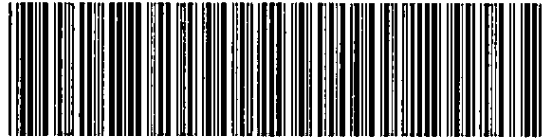

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is TOR2GA, LLC (the "Company"). The Company's principal address is 1875 12<sup>th</sup> Street SE, Largo Florida 33771, and mailing address is P.O. 

**Indemnification**




**CERTIFICATE DESIGNATING**
