

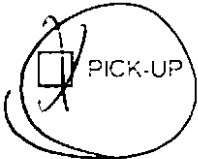

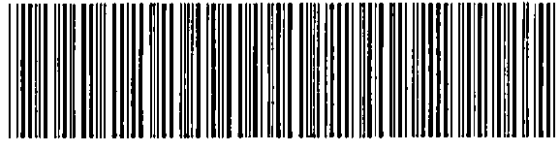

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I
NAME**

The name of the limited liability company is: Machinery Shield, LLC (the "**Company**").

**ARTICLE II

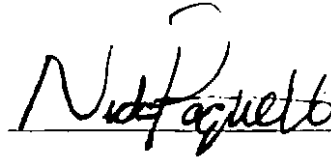
**ARTICLE V

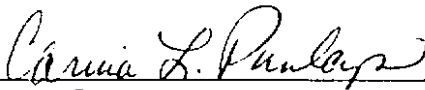
