

Effective at 12:01 a.m. on the date of this filing, Pasture Prime Family Farm, LLC, a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization pursuant to Section 605, Fla. Stat.

ARTICLE 1 NAME

The name of the limited liability company shall be Pasture Prime Family Farm, LLC

ARTICLE 2 DURATION

The period of duration of the Limited Liability Company shall be perpetual, unless the Liability Company is dissolved pursuant to provisions of the Florida Limited Liability Company Action the Articles of Organization of the Limited Liability Company, or the Operating Agreement of the Limited Liability Company.

ARTICLE 3 PURPOSE
