The Company shall be managed by one or more managers as provided in the Company's Operating Agreement; and the initial manager of the Company shall be MONICA L. MILES, OD.

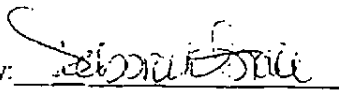
