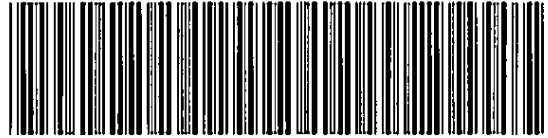

The mailing address and street address of the principal office of the Limited Liability Company is 632 Gamewell Avenue, Maitland, Florida 32751.


ARTICLE III - MANAGEMENT

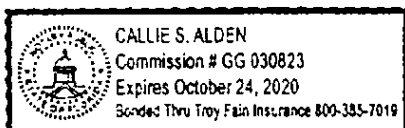
