**AMENDMENT TO THE  
ARTICLES OF ORGANIZATION

The undersigned, for the purpose of amending the Articles of Organization of TCC COMMERCIAL PROPERTIES, LLC pursuant to §605 of the Florida Revised Limited Liability Company Act, F.S., hereby makes, acknowledges, and files this Amendment to the Articles of Organization of TCC COMMERCIAL PROPERTIES, LLC. The original Articles of Organization were filed with the Florida Department of State effective on January 28, 2020 and were amended on February 6, 2020. The Amendment is set forth as follows:

1. The name of this Company is TCC COMMERCIAL PROPERTIES, LLC.
2. The Articles of Organization of TCC COMMERCIAL PROPERTIES, LLC, have been amended by deleting Article IV in its entirety and by substituting in lieu thereof the following Article:

Article IV

The Company shall be managed by a Manager. The Manager as of the date of these Articles is Theresa C. Cook, who shall manage the Company in accordance with the terms of the Operating Agreement of the Company, if any, and applicable law.

3. The referred to Amendment was adopted by the Company on August 26, 2021 by the Members of the Company.

4. Upon the filing of these Articles of Amendment by the Department of State, the above referred to Amendment shall become effective and the Articles of Organization of TCC COMMERCIAL PROPERTIES, LLC shall be deemed to be amended accordingly.
