**ARTICLES OF ORGANIZATION  
OF

The undersigned, John G. Wellborn, a natural person competent to contract and an authorized representative of Live Well Beach Wear, LLC, hereby presents these Articles of Organization as the Articles of Organization of Live Well Beach Wear, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is Live Well Beach Wear, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

**ARTICLE III – PURPOSE AND POWERS**

**ARTICLE V – REGISTERED OFFICE AND AGENT**

**ARTICLE VI – MANAGEMENT**
