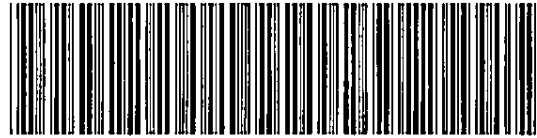

The name of the Florida Limited Liability Company is **KBC Banana Plantation, LLC.**


