ARTICLES OF ORGANIZATION
of
TONY'S CAR WASH AND DETAIL OF PVB, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Tony's Car Wash and Detail of PVB, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 830-13 A1A N. #519, Ponte Vedra Beach, Florida 32082.

ARTICLE II

PURPOSES AND POWERS
