

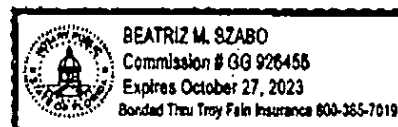

**ARTICLES OF ORGANIZATION  
OF  
SIMPLE GRACES JEWELRY, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Simple Graces Jewelry, LLC (the "Company"). The Company's principal and mailing address is 802 East Plymouth Street, Tampa, Florida 33603. 




