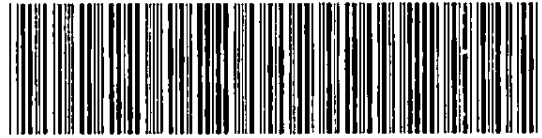

**ARTICLE II– PRINCIPAL OFFICE**




