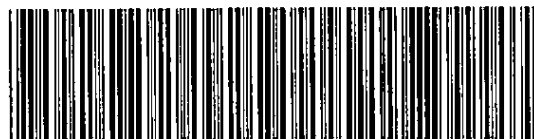

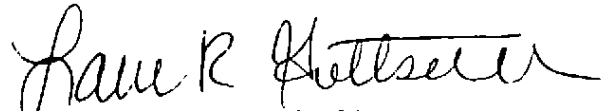

The effective date of the company is the date these Articles of Incorporation are filed with the Secretary of State of the State of Florida.

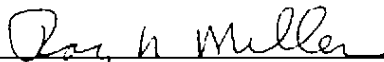
