ARTICLES OF ORGANIZATION OF 9 PALM DRIVE, LLC

- 1. Name. The name of this limited liability company is 9 PALM DRIVE, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
- 2. <u>Place of Principal Office.</u> The physical address and mailing address of the Company is 7 Palm Drive, Key West, Florida 33040.
