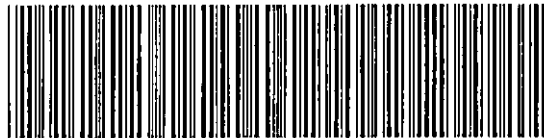

The Company's name is KDOC LLC. The Company is manager-managed. Kevin O'Connell is an initial manager of the Company.




