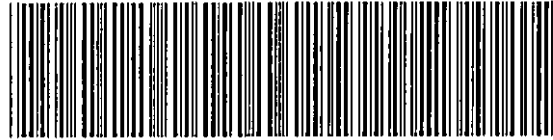


ARTICLE VII
