**ARTICLES OF ORGANIZATION**  
*of*

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be SST Properties of Fernandina, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 3106 B South Fletcher Avenue, Fernandina Beach, Florida 32034.

**ARTICLE II**

**PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 
**ARTICLE VII****DURATION AND COMMENCEMENT**
