Green, Ph.D., LLC, hereby presents these Articles of Organization as the Articles of Organization of Paul C. Green, Ph.D., LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Paul C. Green, Ph.D., LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
