"ARTICLE I: NAME AND MAILING ADDRESS:

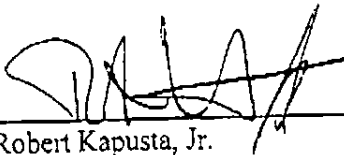
