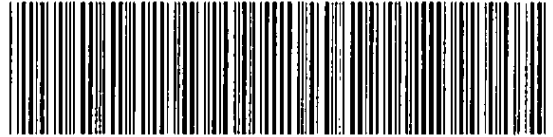

**AMENDMENT TO ARTICLES OF ORGANIZATION  
OF

All other provisions of the Articles of Organization for Florida Limited Liability Company ("Articles") for VALIANT DELIVERY SERVICE LLC are governed by the Operating Agreement and any amendments thereto, hereinafter. In the event that there is any conflict whatsoever between the Articles and Operating Agreement, the Operating Agreement shall control.
