

**ARTICLES OF ORGANIZATION
OF
PURE ESSENCE MEDICAL SPA, LLC**

The undersigned, TAWNEY CHAPMAN, as the subscriber to these Articles of Organization, hereby presents these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 605.

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**




