ARTICLES OF ORGANIZATION OF CHART CONNECTION II LLC

The principal office and mailing address of the Company is as follows: 1524 N.E. 174th St., North Miami Beach, FL 33162.


ARTICLE III REGISTERED AGENT AND OFFICE
