The mailing and street address of the principal office of the limited liability company is 100 S. Tampa Street, Suite 2300, Tampa, FL 33602.

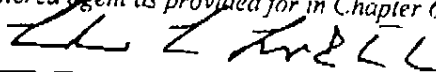
**III. EXISTENCE**

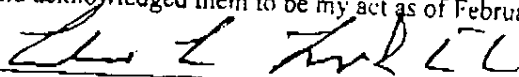
