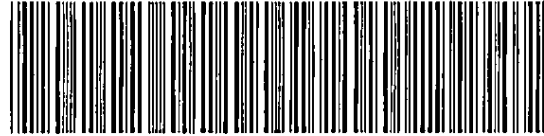

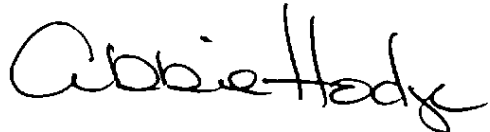

ARTICLE X - AMENDMENT

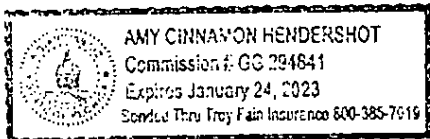

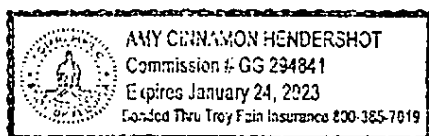
