**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION  
OF  
INVESTIGATIVE ANALYSIS LLC**

Pursuant to the Florida Revised Limited Liability Act, INVESTIGATIVE ANALYSIS LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment to its Articles of Organization.

**FIRST:** The Articles of Organization for the company were filed on February 12, 2020 and assigned Florida document number L20000050240.

**SECOND:** Article III of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:

**ARTICLE III**  
**INDEMNIFICATION**
