The undersigned, JASON WHITE and CINDY WHITE, natural persons competent persons to contract and members of WHITE BUSINESS VENTURES, LLC, hereby present these Articles of Organization as the Articles of Organization of WHITE BUSINESS VENTURES, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is WHITE BUSINESS VENTURES, LLC. This limited liability company is referred to in these Articles as the "Company."

**ARTICLE II – Principal Office Address**

The mailing and street address of the Company's initial principal office is 286 Champion Court, Destin, FL 32541. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III – Purposes and Powers**

The Company shall be managed by a manager or managers who shall be appointed, removed or replaced by a majority in interest of the members in accordance with the terms of the Operating Agreement for the Company. 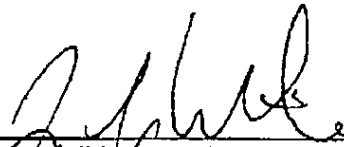

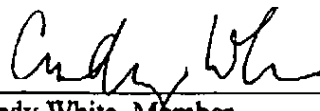

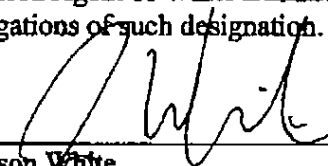
