The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes Chapter 605, as amended (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company is CSF-6178 Holdings, LLC (the "Company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company is 8435 SW 80<sup>th</sup> Street, Suite 2, Ocala, FL 34481.

**ARTICLE III - DURATION**

The period of duration for the Company shall be perpetual.

**ARTICLE IV – PURPOSE; POWERS**

The Company is a limited liability company, organized and at all times to be operated exclusively for charitable, educational and/or scientific purposes as detailed in Section 501(c)(3) of the Internal Revenue Code. Specifically, the purposes for which the Company is organized are to be exclusively for the benefit of, to perform the functions of and to carry out the purposes of Circle Square Foundation, a 501(c)(3) entity which is the initial member of the Company (the "Member"). The Company, in connection with furthering its stated purposes, is authorized to engage in any lawful business that may be engaged in by a limited liability company organized under the Act, provided, however, that all of the same is undertaken solely in accordance with the purposes of the Member, the Member's organizational documents and the Member's tax exempt status under Section 501(c)(3) of the Internal Revenue Code, provided, further, that the Company does not conduct any activity that could jeopardize the Member's qualification under Section 501(c)(3) of the Internal Revenue Code.

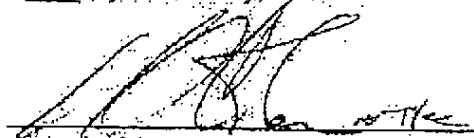

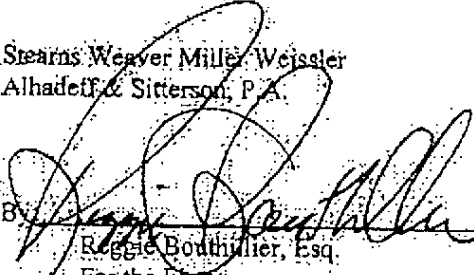
