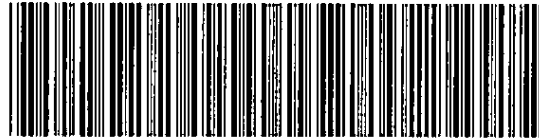



ARTICLES OF ORGANIZATION OF KMJ GROUP, LLC
