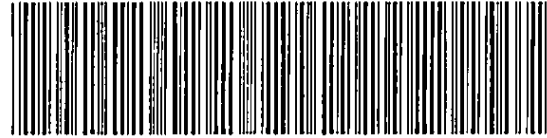

ARTICLE X – AMENDMENT

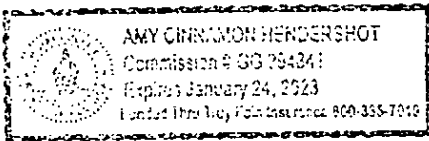

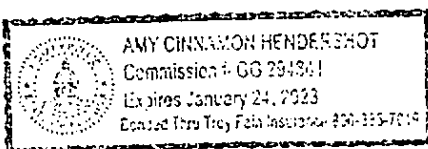
