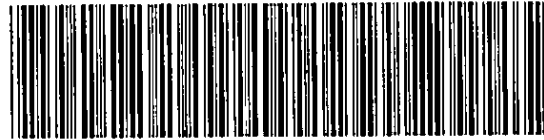



ARTICLES OF ORGANIZATION
OF
CRYSTAL RIVER PARTHENON BUILDING, L. L.C.

These Articles of Organization of Crystal River Parthenon Building, L.L.C., are being duly executed and filed to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes. (the Act).

ARTICLE I

Name

Subject to any restrictions imposed by law of the Regulations of the Company, the Board of Directors may exercise all of the powers of a Manager under the Act. Any action by the Board of Directors shall be deemed to be an action by the Managers of the Company for the purposes of the Act or otherwise. In the event there is more than one Member, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, the surviving and/or remaining Member(s) shall have the right to continue the Company or to terminate and liquidate the Company.
