**ARTICLES OF ORGANIZATION
OF

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

**ARTICLE I
Name**

The name of the limited liability company shall be **BB SUNSET DRIVE LLC**.

**ARTICLE II
Address and Place of Business**

Period of Duration**

The operating agreement shall be repealed or altered only by the members of the limited liability company, in the manner set forth in the operating agreement.


